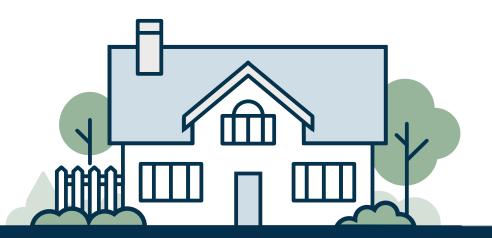
COVID-19 Pandemic Is Driving Financial and Life Impacts, but Mobility and Housing Preferences Remain Stable for Now

National Housing Survey®

Consistent with Q2 findings, the COVID-19 pandemic continues to have a greater impact on the lives and finances of renters, minorities, and lower-income households.

Financial and Lifestyle Impacts of Coronavirus



Renters, those with lower incomes, and Hispanic and Asian Americans are more likely to have lost their jobs or been furloughed due to coronavirus.

- Those with lower incomes are more than twice as likely as higher-income households to be concerned about losing their jobs.
- Likewise, **renters** and **minorities** are significantly more likely to be concerned about losing their jobs.



Renters are twice as likely as homeowners with a mortgage to be concerned about their ability to pay their bills.

- Lower-income households are more than twice as likely as those with higher incomes to be concerned.
- Members of minority populations are nearly twice as likely as White, non-Hispanic respondents to be concerned.



Almost one-third of survey respondents have started working from home, though lower-income households are significantly less likely than those with higher incomes to work from home.

- Black respondents are twice as likely as White, non-Hispanic respondents to have had friends or family move in during the pandemic.
- Hispanic respondents are more likely than White, non-Hispanic respondents to have experienced disruptions in childcare.



To date, mobility does not appear to have been impacted substantially by the pandemic, as timelines for moving as well as where and how people want to live has generally remained stable.

Impact of Coronavirus on Mobility and Housing Preferences



Most households have not changed their plans to move due to the coronavirus – only 6% have moved up their plans, and 11% have delayed their plans.

 The net change to delay plans to move is consistent for those who report living in urban, suburban, and rural areas.



The pandemic has not impacted households' predictions of when they will move next – this has remained largely consistent over the last several years.

• 2 in 5 respondents say they **never plan to move**, while just over a quarter plan to move within the next 3 years.



Respondents are most likely to prefer to stay in the type of area (urban, suburban, or rural) in which they say they live.

 Nearly half of those who report living in an urban area would prefer to remain in an urban area, while a quarter would move to the suburbs.



Compared to Q2/Q3 2019, households' preferences on the size, pricing, and location of their next home have not changed much.

 Just about half would prefer to move to a house that's about the same size and price, and just over 2 in 5 would prefer to move to a different city or town – similar shares as seen last year.



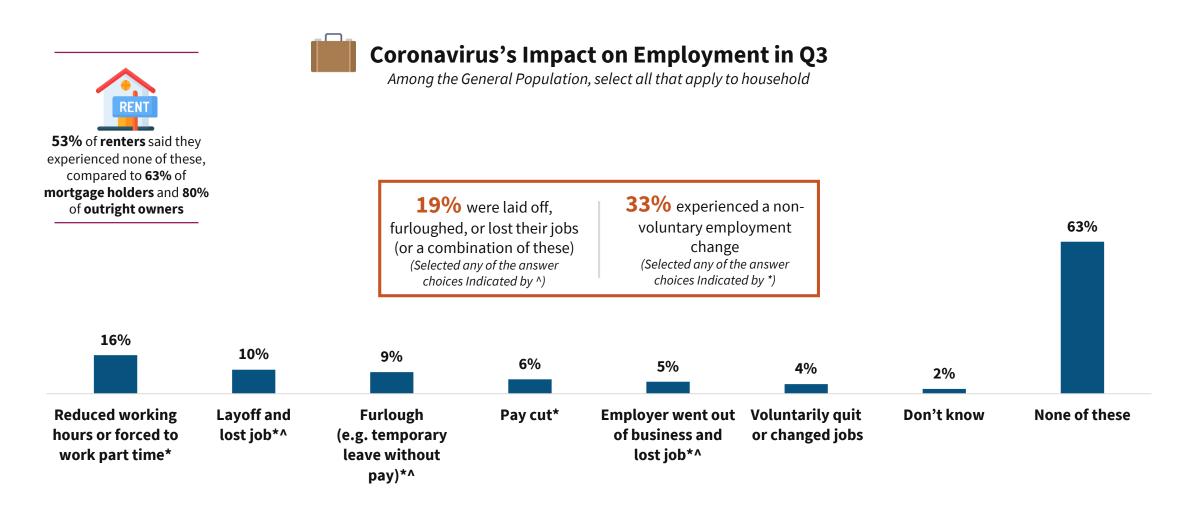
Implications

- Given our survey results report a more significant impact of the COVID-19 pandemic on renters, minorities, and lower-income households, and as new stimulus and relief measures remain uncertain at the time of writing, there is a need to bring a stronger focus on the challenges these groups face. It will be important to continue to:
 - Improve awareness of the available housing relief options through targeted outreach.
 - Design strategies to address the growing difficulties to maintain and build credit scores and savings for upfront housing costs, such as the down payment or rental deposit, that could increase gaps in the homeownership rate and overall wealth building.
- A significant portion of the population who did not work from home is now doing so, especially higher-income workers. Though consumers' attitudes about moving and home/location preferences appear to be generally stable during the pandemic, changing work patterns may eventually impact our life and housing choices.



Financial Impact and Life Disruptions from COVID-19

Nearly one-third of respondents have experienced changes in their employment as a result of the coronavirus.

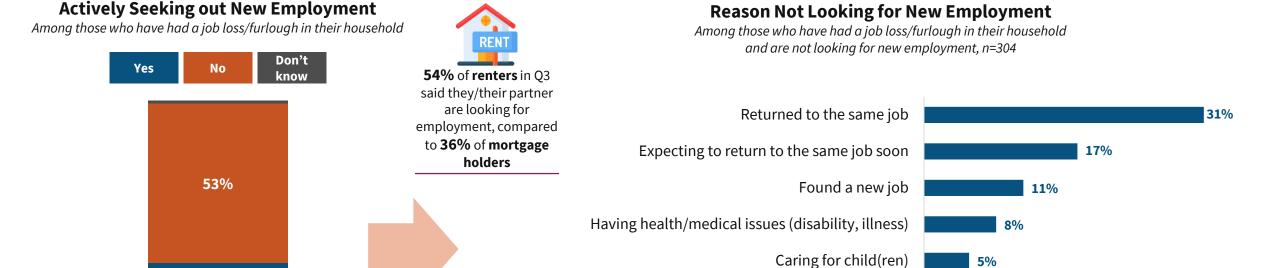

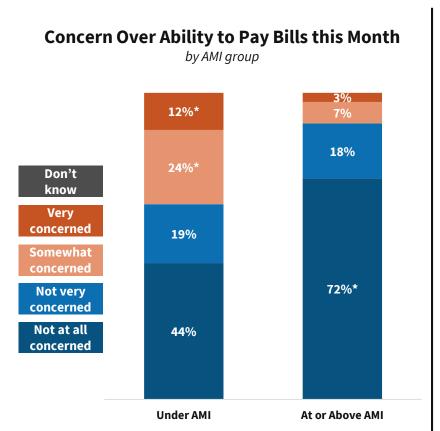

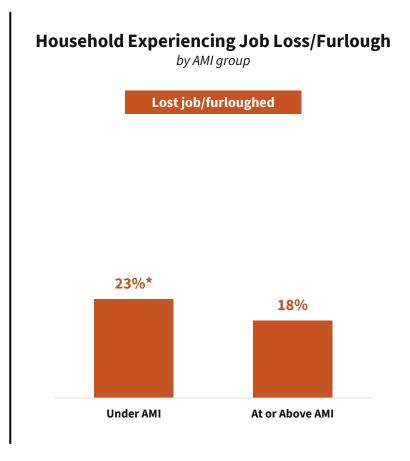

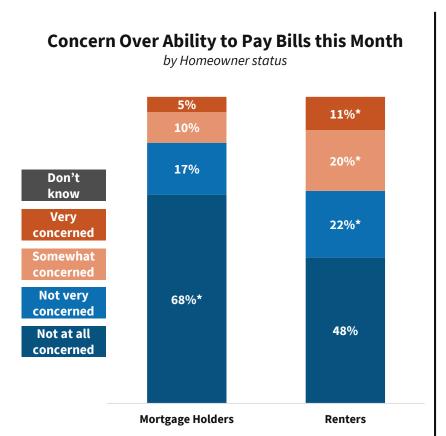

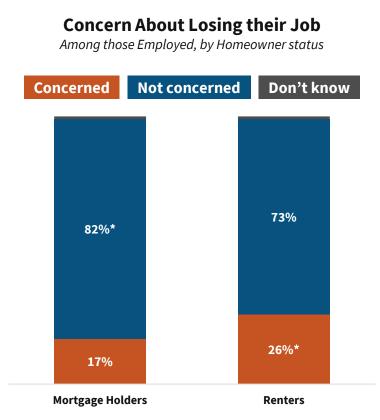

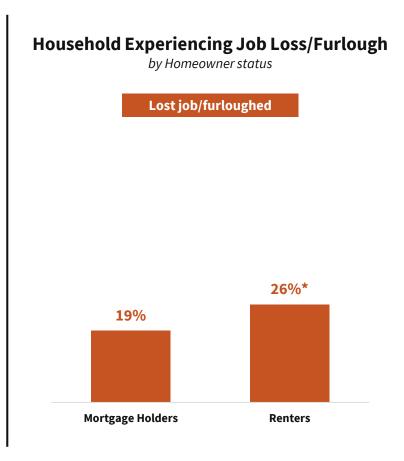

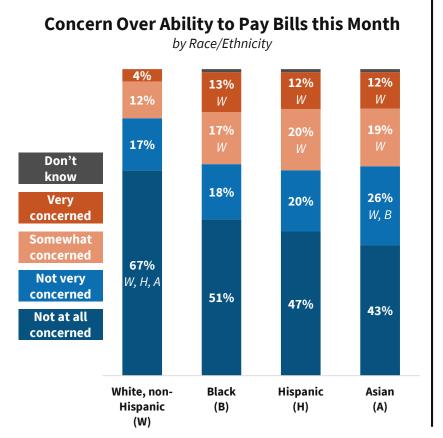

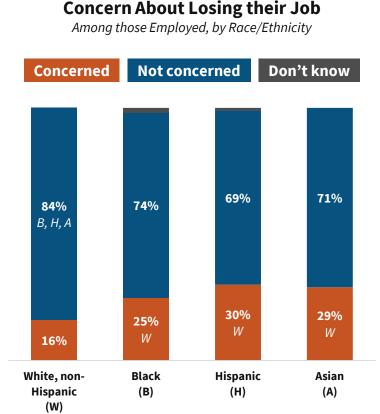

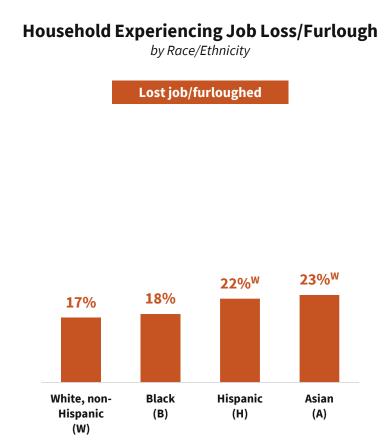

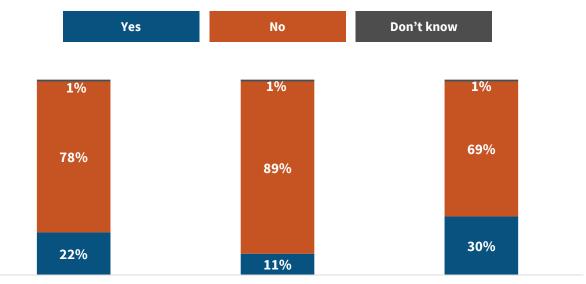

Nearly 1 in 5 households have experienced disruption of childcare, 1 in 10 have had family/friends move in, and one in three have started working from home.

29% of **Hispanic Americans** have experienced a disruption in childcare in Q3, compared to **19%** of **White, non-Hispanic Americans.**

21% of **renters** have experienced a disruption in childcare in Q3 compared to **28%** of **mortgage holders**



18% of **Black Americans** have had friends or family move in compared to **9%** of **White, non-Hispanic Americans**



22% of those **under AMI** have experienced working from home in Q3 compared to **38%** of those **at or above AMI**.





Mobility and Housing Preferences

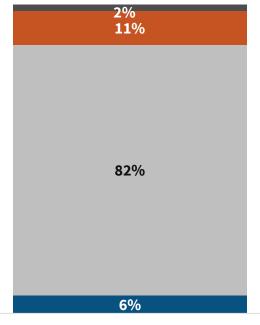
For the most part, households have not changed their plans to move due to the coronavirus, and the net change is to delay moving.

The net change to delay plans to move is consistent across areas. 15% have delayed their plans to move and 10% have moved up their plans among those who report living in urban areas, compared to 11% and 5% respectively among those who report living in suburban areas and 7% and 2% respectively among those who report living in rural areas.

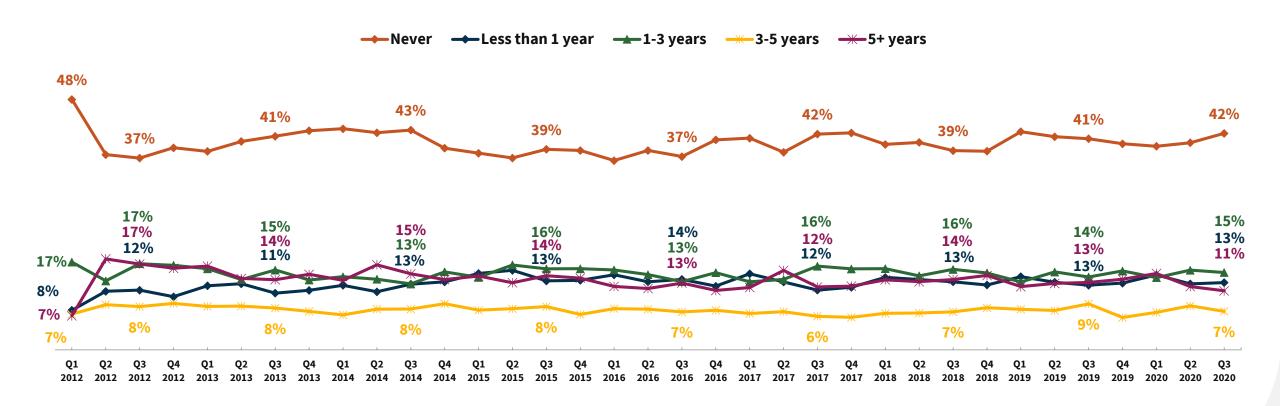

Among the General Population

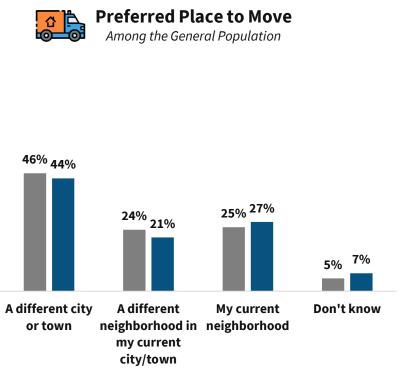


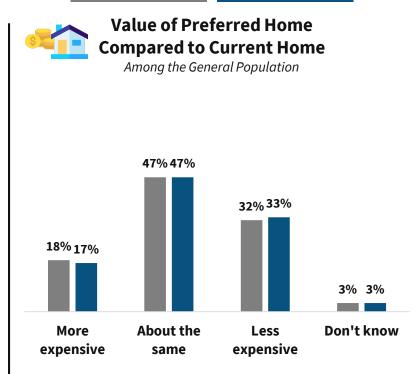
Respondents' preferences on the location, price, and size of their next home have remained mostly unchanged since last year.

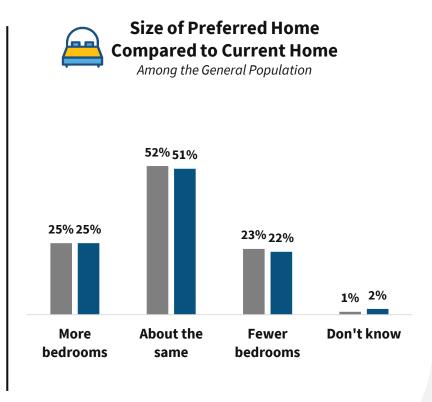
Preferences for Next Home

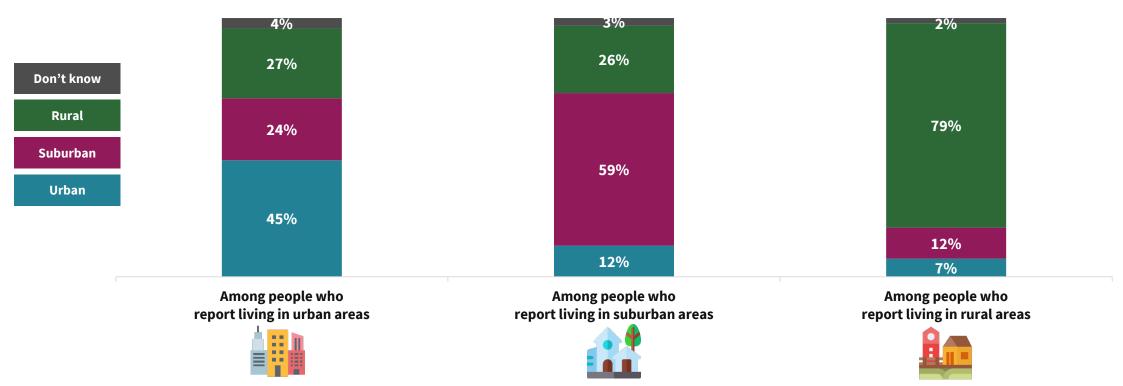

Q: Would you describe the area you currently live as rural, suburban, or urban area?

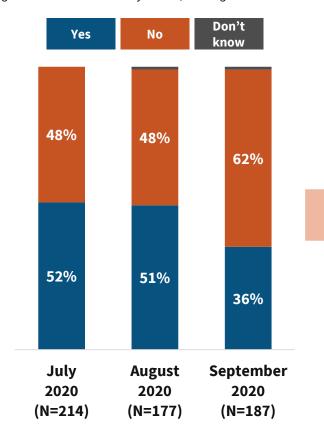

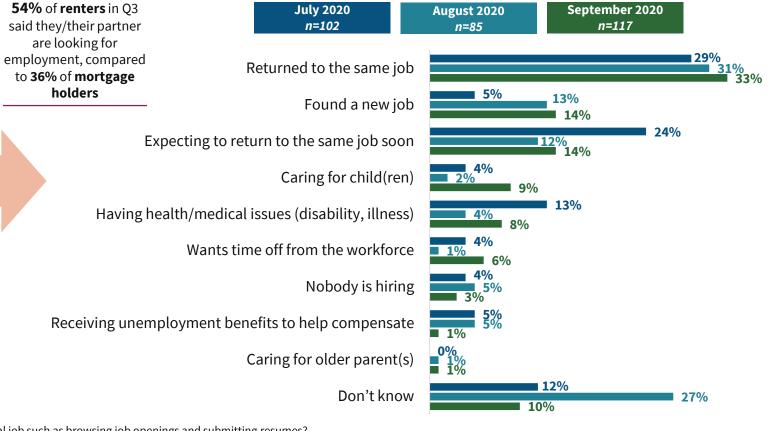
Actively Seeking out New Employment

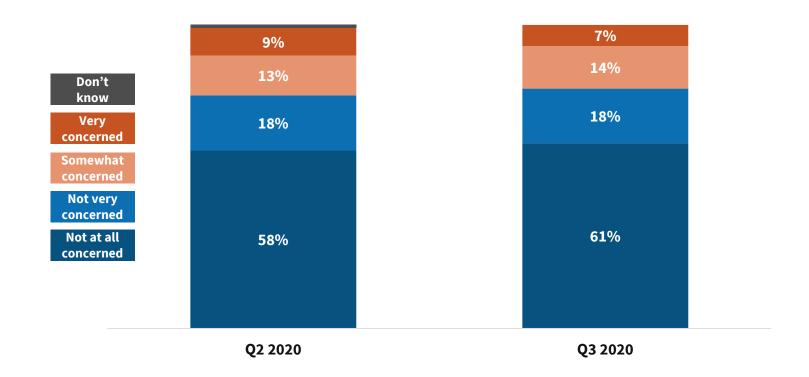

Among the General Population





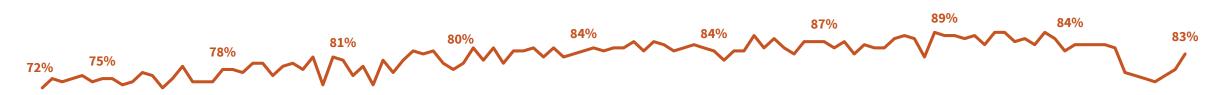

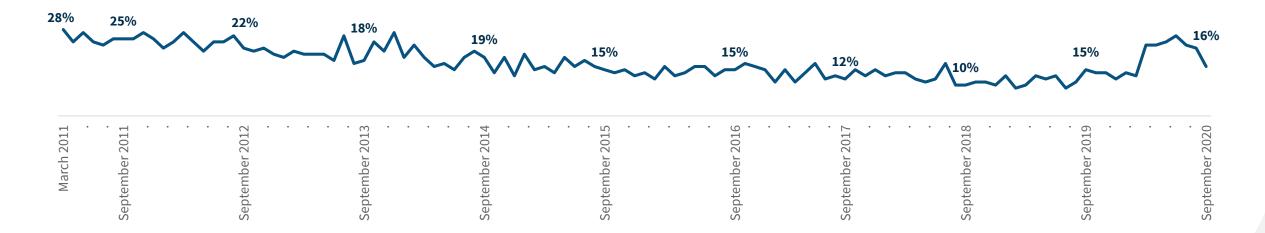

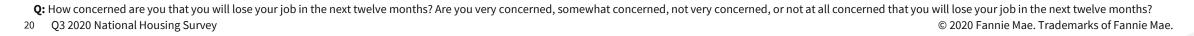
Percent of employed respondents who say they are concerned or not concerned about losing their job

Among the General Population who are Employed





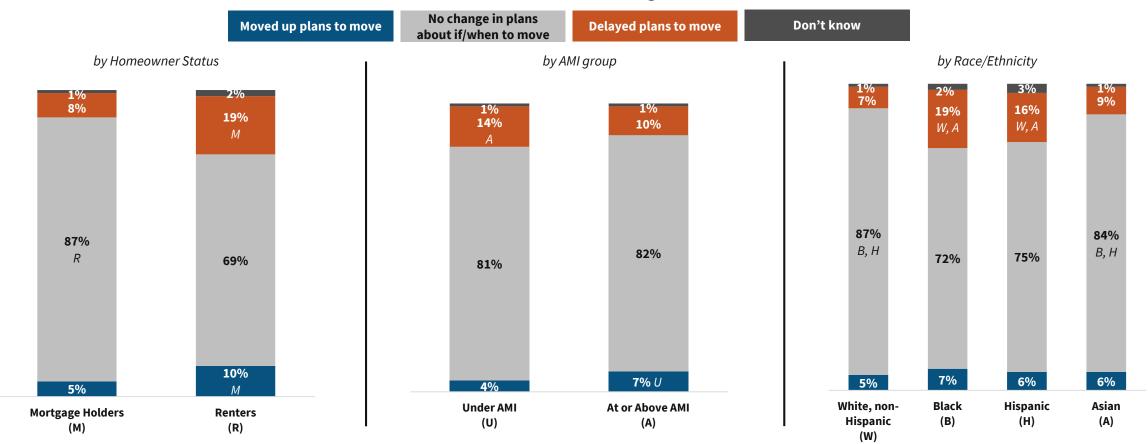






Renters, those under AMI, and Black and Hispanic Americans are more likely to delay their plans to move, yet overall are still are not likely to change their plans.

A Note on April-July 2020 Survey Collection

Due to the spread of the novel coronavirus (COVID-19), PSB's in-house phone room closed due to a shelter in place order in Denver, CO. Because of this PSB has partnered with Opinion Access to conduct the NHS interviews on our behalf. PSB continues to process and analyze the data and complete all regular deliverables.

While Opinion Access has call centers based in in Florida, they also have a very extensive remote workforce that can conduct interviews from their homes. This ensures our continued work on the NHS even if their call centers are forced to close or if a portion of the work force gets sick.

PSB trained all interviewers from Opinion Access to ensure interviewing is consistent with PSB's procedures. We also are monitoring interviews for quality control. This minimized any noise in the data from using different interviewers. PSB also regularly reviews the results of the interviews as they are completed to ensure everything is fielding properly.

There were no changes in the sample composition, as PSB provided Opinion Access with the survey sample and dialing procedures. The sample quotas and targets remained unchanged from previous months and the data was weighted by PSB in the same way as past months to be representative of the US population.



Research Methodology: Q3 2020

- Each month, beginning in June 2010, approximately 1,000 live (not automated) telephone interviews with Americans age 18 and older via landline and cell phone are conducted by PSB, in coordination with Fannie Mae. For the sample to accurately represent the U.S. population, 70% of calls are made to cell phones. The margin of error for the total sample is ±3.1% at the 95% confidence level and larger for sub-groups. Most of the data collection occurs during the first two weeks of each month.
- The General Population data presented in this study has been weighted to make it reflective of the U.S. Census American Community Survey demographic statistics in terms of gender, age, race/ethnicity, income, education, housing tenure, and the Centers for Disease Control (CDC) National Health Interview Survey (NHIS) phone type statistics.
- Respondents can volunteer a "don't know" response on each question, which is why, in some cases, the total responses may not add up to 100%.
